on the guidelines for the subject *Scientific research in practice* implemented in the second year at the Doctoral School

Pursuant to §12(1)(7) of the Regulations of the Doctoral School of the Maria Grzegorzewska University of 20 March 2019, the consolidated text of which constitutes Appendix No. 1 to Resolution No. 155/2021 of the Senate of the University of 28 April 2021, in connection with the curriculum of the Doctoral School of the University, constituting Appendix No. 1 to Resolution No. 137/2019 of the Senate of the University of 20 March 2019, I hereby order the following:

§ 1

1. As part of the implementation of the subject *Scientific research in practice*, the task of the doctoral student is to join a research team of his/her choice implementing a research project/grant. A doctoral student should actively participate in the research and organizational work of his or her chosen research team. This activity is designed to familiarize the student with the principles of conducting different types of scientific research, depending on the individual choice and specialization of the doctoral student.
2. In one semester a doctoral student is required to complete 30h, in the whole year 60h. These hours can be completed in collaboration with one research team or several ones.
3. A statement of anticipated participation in the work of the research team of one's choice (Appendix No. 1 to this Order) must be submitted by the end of October of the academic year in question to the Office for Academic Promotion.
4. In order to make the final settlement of the implementation and receive credit for the course "Scientific research in practice", the doctoral student submits a confirmation of participation in the project (Appendix No. 2 to this Order), which shows the amount of hours and the tasks performed, confirmed by the signature of the project/grant manager. This certificate must be submitted by the end of June to the Office for Academic Promotion. On the basis of this documentation, the Head of the Doctoral School gives credit for the course.

§ 2

The Order comes into force on the date it is signed.
