

Resolution No. 362/2022
Senate of the Maria Grzegorzewska University

of 22 June 2022

on changing the resolution on the adoption of the curriculum of the Doctoral School at the Maria Grzegorzewska University, the rules for making an individual research plan, and the Regulations for professional internships at the Doctoral School of the Maria Grzegorzewska University

Pursuant to Article 198(3) and Article 201(3) and (4) of the Act of 20 July 2018 – The Law on Higher Education and Science (Journal of Laws of 2022, item 574, as amended) and pursuant to § 21(1)(13) and § 21(2) of the Statute of the Maria Grzegorzewska University of 16 May 2019, the consolidated text of which is attached to Resolution No. 216/2021 of the Senate of the Maria Grzegorzewska University of 30 June 2021, after consultation with the doctoral student council, it is resolved as follows:

§ 1

The curriculum of the Doctoral School is amended in such a way that in Resolution No. 137/2019 of the Senate of the Maria Grzegorzewska University of 20 March 2019 on the adoption of the curriculum of the Doctoral School at the Maria Grzegorzewska University, the rules for making an individual research plan, and the Regulations for professional internships at the Doctoral School of the Maria Grzegorzewska University, as amended by Resolution No. 305/2020 of the Senate of the Maria Grzegorzewska University of 31 March 2020 and Resolution No. 214/2021 of the Senate of 30 June 2021, the following changes are made:

- 1) The content of Appendix No. 1 is amended and replaced with a new wording in accordance with the content of Appendix No. 1 *DESCRIPTION OF THE CURRICULUM* hereto;
- 2) The content of Appendix No. 2 is amended and replaced with a new wording in accordance with the content of Appendix No. 2 *CANDIDATE PROFILE FOR APPLICANTS FOR THE DOCTORAL SCHOOL AT THE MARIA GRZEGORZEWSKA UNIVERSITY AND DESCRIPTION OF THE ENROLLMENT PROCESS* hereto;
- 3) The content of Appendix No. 3 is amended and replaced with a new wording in accordance with the content of Appendix No. 3a *LEARNING OUTCOMES* hereto;
- 4) Appendix No. 3b *CLASS DESCRIPTION* shall be added after Appendix No. 3a.
- 5) The content of Appendix No. 4 is amended and replaced with a new wording in accordance with the content of Appendix No. 4 *CURRICULUM* hereto;
- 6) The content of Appendix No. 5 is amended and replaced with a new wording in accordance with the content of Appendix No. 5 *INDIVIDUAL RESEARCH PLAN (IRP) – GUIDELINES* hereto;

- 7) The content of Appendix No. 6 is amended and replaced with a new wording in accordance with the content of Appendix No. 6 Regulations for professional internships at the Doctoral School of the Maria Grzegorzewska University hereto;

§ 2

1. The Resolution shall enter into force on 1 October 2022.
2. The changes introduced in § 1 apply to students starting education in the 2022/2023 academic year.
