Pursuant to § 12(1)(7) of the Regulations of the Doctoral School of the Maria Grzegorzewska University, adopted by Resolution No. 138/2019 of the Senate of the University of 20 March 2019 on the adoption of the Regulations of the Doctoral School run by the Maria Grzegorzewska University, as amended, the consolidated text of which constitutes Appendix No. 1 to Resolution No. 346/2022 of the Senate of the University of 27 April 2022, I order as follows:

§ 1

- 1. I approve the rules of scientific internships of doctoral students of the Doctoral School of the Maria Grzegorzewska University, in accordance with Appendix No. 1 to this Order.
- 2. I approve the template of the application for internship approval, as set forth in Appendix No. 2 to this Order.
- 3. I approve the template of the application form for information of a doctoral student on the sources of funding for a research internship, in accordance with Appendix No. 3 to this Order.

- 4. I approve the template of the application for internship funding, in accordance with Appendix No. 4 to this Order.
- 5. I approve the template for the planned internship form, in accordance with Appendix No. 5 to this Order.
- 6. I approve the template of the report of a doctoral student of the Doctoral School of the Maria Grzegorzewska University in Warsaw, in accordance with Appendix No. 6 to this Order.

The Order comes into force on the date it is signed.

Appendix No. 1 to the Order No. 1/2023 of the Head of Doctoral School of 20 February 2023

Principles of the scientific internship of doctoral students

as part of the studies at the Doctoral School of the University

In support of scientific development and qualification improvement, doctoral students of the Doctoral School of the University may pursue a domestic/foreign research internship.

Research internship - explanations

- 1. A research internship is understood as a stay at a university/academic unit other than the home university/academic unit held for the purpose of conducting scientific research or acquiring knowledge and skills for conducting scientific research in accordance with the Individual Research Plan of the doctoral student.
- 2. The purpose of the research internship is, in particular:
 - a. conducting scientific research or participating in research and development work in cooperation with scientists of another university/academic unit,
 - b. obtaining knowledge and skills on how to conduct scientific research,
 - c. obtaining information/data related to the research conducted as part of the dissertation being prepared,
 - d. exchanging experience and knowledge in the thematic area related to the scientific work of the doctoral student.
- 3. The purpose of the research internship must be consistent with the research area and discipline of the doctoral student's dissertation.
- 4. The duration of the internship is determined individually depending on specific needs.
- 5. The doctoral student may pursue a research internship throughout the course of their education.

Documentation of the doctoral student's research internship

- 1. Approval for a research internship is granted by the Head of the Doctoral School, after reviewing the submitted documentation.
- 2. A doctoral student applying for a research internship submits the following to the Head of the Doctoral School:
 - a. an application for a research internship with the consent of the supervisor, according to the template specified in Appendix No. 2.
 - b. the planned course of the doctoral student's research internship approved by the supervisor and the internship supervisor on the side of the host institution, according to the template specified in Appendix No. 5.

- c. a confirmation of acceptance for a research internship from the research unit/research supervisor or a copy of correspondence with the center to which the doctoral student goes for the internship.
- d. information on the sources of funding for the research internship, according to the template specified in Appendix No. 3.
- e. other documents, if needed.
- 3. The documents referred to above are submitted by the doctoral student to the Office of the Doctoral School.
- 4. In the case of a trip to participate in a foreign internship, the rules indicated in the legal acts in force at the University on the conditions and procedure for delegating scientific employees abroad are additionally applied.
- 5. When applying for a foreign research internship, the document referred to in item 2b shall be submitted in English according to the template specified in Appendix No. 5 to this Order.

Funding of a research internship

- 1. The doctoral student, in consultation with the supervisor, determines the approximate cost of the research internship and indicates the sources of its financing.
- 2. The costs of the internship travel, per diem, accommodation, can be covered, in particular, with funds from:
 - a. scientific projects financed by external institutions, e.g. by NCN, NCBiR,
 - b. academic exchange programs,
 - c. university research projects,
 - d. the budget of the Doctoral School, in case the doctoral student or his/her supervisor applied for and did not obtain funds as part of the sources listed in items a-c.
- 3. In the case indicated in item 2d, the doctoral student may receive funding to cover the costs of the internship in part or in full.
- 4. The funding referred to in item 3 may be received by a doctoral student only once in the course of education at the Doctoral School of the University.
- 5. A doctoral student applying for funding/subsidies for a research internship from the funds of the Doctoral School attaches the following to the application, the template of which is attached as Appendix No. 4:
 - a. an approximate calculation of costs,
 - b. justification of the application for funding/subsidies for the internship with documentation proving the search for other sources of funding.
- 6. Funding for the scientific internship is provided on the basis of delegation in accordance with the current regulation of the Minister of Labor and Social Policy on the receivables

to which an employee working in a state or local government unit of the budgetary sphere is entitled for business travel.

Report on the implementation of the research internship

- 1. The doctoral student submits to the Head of the Doctoral School a report on the implementation of the research internship, the template of which is attached as Appendix No. 6, no later than 3 months after the end of the internship.
- 2. The report should address the stated objectives outlined in the internship program and list and document the effects of the internship, e.g. publications, speeches at seminars, conferences, scientific consultations and/or completed stages of the dissertation.
- 3. The report should be accompanied by:
 - a certificate from the academic unit hosting the research internship/research supervisor, certifying the implementation and completion of the internship (indicating dates and location),
 - b. opinion of the internship supervisor on the implementation of the internship by the doctoral student (referring to the effects planned to be achieved in the planned course of the internship).
- 4. On the basis of the submitted report, the Head of the Doctoral School assesses the degree to which the assumed objectives of the research internship have been met and makes a decision on the recognition of the research internship.
- 5. A doctoral student of the Doctoral School, doing a research internship, is obliged to affiliate to the University the results of the scientific work produced as a result of the internship.

Financial settlement of the internship

- The doctoral student submits a financial settlement together with documents confirming
 the expenditure of funds and documents indicated in the legal acts in force at the
 University on domestic and foreign trips of employees and doctoral students
 (delegation) to the Research Service Office through the Office of the Doctoral School
 within 14 days after the end of the research internship.
- 2. Failure to settle the internship may be considered a violation of the doctoral student's duties, with consequences ensuing from the Regulations of the Doctoral School.
