DSOUD DECLARATION OF UNIVERSITY SOCIAL RESPONSIBILITY


The particular role of universities, as a place for creating and transferring knowledge about the reality surrounding us, obligates them to take into account and apply the principles of social responsibility in all areas of their activity, as well as to promote these principles among stakeholders.

Taking into consideration the best interests of higher education in Poland, aware of our role in implementing the principles of sustainable development, ensuring high quality research and education, and caring for the comprehensive development of the academic community, we commit ourselves to:

- 1) Fostering the ethical values listed, among others, in the "Code of Ethics for Research Staff", in particular: conscientiousness, objectivism, independence, openness, and transparency.
- Shaping social and civic attitudes of future elites 2) conducive to building community, creativity, openness, and communication, along with social sensitivity and work culture.
- 3) Promoting the idea of equality, diversity, tolerance, as well as respecting and protecting human rights in reference to the entire academic community and its environment.
- 4) Expanding curricula to include such issues as ethics and corporate social responsibility, sustainability, and social innovation.
- 5) Realizing projects that implement principles of social responsibility, in particular those concerning diversity management in the workplace, corporate volunteering, promotion of ethics principles, inter-sectoral cooperation, and cause-related marketing.
- Undertaking scientific research and 6) implementation work that, in the framework of partnership with other academic centers from around the world, enterprises, public administration, and non-governmental organizations, will be able to contribute towards resolving fundamental social problems.

- 7) Developing inter-institutional, national, and international cooperation, enabling the adaptation and strengthening of best practices in the range of university social responsibility.
- 8) Taking care for universities' governance, basing their management on the foundations of social responsibility, both in strategic documents as well as in resulting activities that serve the comprehensive development of the academic community and effective realization of universities' mission.
- 9) Ensuring transparency in the activities conducted by universities through, among others, measuring results, promoting and popularizing achievements, as well as designating a person or team for coordinating these activities.
- 10) Conducting actions/ Operating in such a manner as to minimalize the negative impact of activities realized by the academic community and its stakeholders on the natural environment, in all its dimensions.
- 11) Conducting dialogue with stakeholders on the priorities of university social responsibility policy and reporting its results.
- 12) Following the principles of ethics and responsibility in the process of teaching and conducting scientific research, in order to provide stakeholders with optimal conditions for making use of knowledge, intellectual capital, and universities' achievements.

4. History of the creation of the Working Group on University Social Responsibility For years Polish administration has been actively promoting responsible business conduct (RBC) standards for years, recognising the need for extensive education in this area and the need to educate future business leaders.

The platform for dialogue between the public administration and stakeholders in this regard was the Sustainable Development and Corporate Social Responsibility Advisory Board, operating since 2009 (then as an auxiliary body to the Prime Minister). Over the years, the form and scope of activities of the above-mentioned Advisory Board have changed, however, the basic task of the Advisory Board has been to create a space for dialogue and exchange of experiences between public administration bodies, social and economic partners, non-governmental organisations and academic community in the development of corporate social responsibility (CSR/RBC) practices. As part of its tasks, the Advisory Board developed recommendations for the implementation of CSR/RBC standards into public policies in line with the country's socio-economic development priorities.

The Advisory Board consisted of representatives of the government administration, the society, employers' organisations, trade unions, industry and sector associations, NGOs and the scientific and academic community. In total, nearly 70 institutions and organisations have participated in the work of the Advisory Board in recent years. Advisory Board members met several times a year, and in the periods between Advisory Board meetings, work was carried out within the framework of working groups set up according to the needs.

In subsequent iterations of the Advisory Board, the following working groups were engaged in addressing the issues of education and dissemination of corporate social responsibility:

2009-2013

The CSR and education working group (within the Corporate Social Responsibility Advisory Board, a subsidiary body of the Prime Minister)

2014-2015

The Working Group on CSR education and dissemination (within the Corporate Social Responsibility Advisory Board, a subsidiary body of the Minister of the Economy)

2016-2018

The Working Group on CSR education and popularisation (within the Sustainable Development and Corporate Social Responsibility Advisory Board, a subsidiary body of the Minister of Development and Finance)

2018-2024

The Working Group on the social responsibility of universities (within the Sustainable Development and Corporate Social Responsibility Advisory Board, a subsidiary body of the Minister of Investment and Development; from 21 January 2020, a subsidiary body of the Minister of Development Funds and Regional Policy)

From June 2024

The Working Group on University Social Responsibility (USR) (working group set up to support the Minister of Development Funds and Regional Policy on issues of corporate social responsibility and responsible business conduct, in particular the dissemination of these issues and the conduct of research and development work)





5. Development of a definition of the University Social Responsibility and the Declaration of USR

Definition of University Social Responsibility

The result of many meetings and lively discussions by members of the Working Group on CSR education and dissemination and then the Working Group on CSR education and popularisation was the following definition of the university social responsibility:

Social responsibility of a university is a strategic and systemic approach to university management, building collaboration and dialogue with stakeholders that contributes to:

- 1. sustainable development,
- 2. shaping the values and attitudes of civil society,
- 3. supporting academic values and creating new ideas,
- 4. sustaining and developing scientific and teaching competences that have an impact on efficiency of activities and innovation.

The definition of USR, adopted by the members of the Working Group on CSR education and popularisation, set the course of action and area of activity for universities interested in having a positive impact on the surrounding reality. It also became the starting point for the academic community to develop a document aimed to disseminate the principles of social responsibility.

Declaration of University Social Responsibility

The initial idea for the Declaration of USR was born in 2016 and the final version was ready in November 2017.

The development of the Declaration of USR was a bottom-up initiative. It was not imposed administratively but, from the beginning, was supported by the Ministry of Development (whose scope of activity included corporate social responsibility) and the Ministry of Science and Higher Education.

The main pillar of the Declaration of USR are the ethical values included in it, already mentioned in its section 1 (i.e. conscientiousness, objectivism, independence, openness and transparency)¹.

The Declaration of USR was opened for signature for the first time and also presented to the academic community on 16 November 2017 during a conference in Warsaw entitled **'Social Responsibility** of Science – challenges for academic community and business'.

The Declaration of USR was intended to serve as a voluntary commitment by the university to promote sustainability and social responsibility in areas such as educational programmes, management and organisational solutions of the university. Its aim is to 'create broad public awareness of the role of universities in shaping the conditions for sustainable socio-economic development in the country. The implementation of the commitments of the declaration contributes to a more effective adjustment of the educational offer for students to the current economic challenges, including above all the labour market, the inclusion in the subjects of study of topics related to business ethics, social responsibility, environmental impact or cooperation with the community'.³

The Declaration of USR is the document through which one of the most important tasks of the Working Group is realised: the dissemination of the principles of social responsibility of universities.



Joining the ranks of signatories of the Declaration of USR is a voluntary commitment by universities to promote sustainability and social responsibility in the educational programmes as well as management and organisational arrangements of the university. The aim of the document is to create broad public awareness of the role of universities in shaping the conditions for sustainable socio-economic development in the country. Implementing the principles of the Declaration of USR makes it possible to more effectively match the educational offer for students to current economic challenges, including, above all, the labour market. An example of the practical implementation of the Declaration of USR could be the inclusion in educational curricula of topics related to business ethics, social responsibility, the environmental impact of business activities and the importance of dialogue and cooperation with the community.

The Declaration of USR supports universities and academic centres looking for inspiration to improve their university development systems in order to meet the highest standards of management inherent in leading international university centres. It is therefore addressed to all public and private universities offering education in both the humanities and economics.

The motivation of the university to pursue its educational and pedagogical mission in the spirit of modern global education, taking into account trends related to sustainability and social responsibility, is also crucial in these activities. Currently, 160 Polish universities are signatories of the Declaration of USR.





6. Key projects and outcomes of the Working Group on University Social Responsibility



The ambition of the Working Group on University Social Responsibility (USR) is, among other things, to promote good practice in the responsible running of universities, as well as to spread knowledge and dialogue around sustainability issues. This is achieved, among other things, through a number of publications and events, details of which are presented in the following paragraphs.

1) The USR Working Group good practice catalogues

From 2019, the USR Working Group publishes catalogues of good practices of universities in the field of university social responsibility. So far, four such catalogues have been published, each with its own theme. Common to all publications is the understanding of the essence of the USR, which was developed by the Working Group. Issues presented in the catalogues include, but are not limited to: developing ethical attitudes, building academic values and social and academic engagement, managing diversity and countering discrimination, as well as ethics in research.

In one of the catalogues, good practices were assigned to the respective areas of sustainability (ESG: **E**nvironmental, **S**ocial and **G**overnance). An evaluation of practices carried out in earlier years was also conducted to assess which practices had the greatest social and environmental impact. The results of the analysis indicate that universities are undertaking activities in a number of areas, often related to their business profile. They are both self-initiated by universities and implemented in cross-sector partnerships, increasing the synergy of activities.



Good practice catalogues issued in the period 2018-2022

The first catalogue, entitled ,Catalogue of University Social Responsibility Practices in Poland', was published in 2019 as an appendix to the publication 'Social Responsibility: relevance for universities and ways of implementation'. The catalogue included 139 practices from 40 universities. Practices were analysed against the Sustainable Development Goals (SDGs) and the principles of the Declaration of USR. When analysing the practices in terms of the principles of the Declaration, it can be observed that the practices reported by the universities most often fell under principle 2 of the Declaration (44

practices), principle 3 (18 practices), principle 6 (16 practices) and principle 5 (12 practices). The other principles were implemented in fewer practices (from 8 to 2). The reported initiatives were also analysed in terms of the declared UN Sustainable Development Goals (SDGs). The following were most frequently identified: SDG 4 (39 practices), SDG 3 (20 practices), SDG 10 (14 practices) and SDG 7 (13 practices).

In 2020, the ,Catalogue of good practices for the University Social Responsibility in the era of the COVID-19 pandemic' was published. The publication included 171 activities carried out by 57 universities. Equipment support and protection measures, scientific activities, psychological support, educational activities, volunteering, material assistance, communication and information activities, other initiatives were the categories according to which the submitted practices were analysed.



The 2021 edition is a ,Catalogue of good practices for the University Social Responsibility with an ethical and non-discriminatory dimension'. This edition of the Catalogue is dedicated to academic values, including the development of ethical attitudes, countering various manifestations of discrimination, as well as social engagement at the university. A total of 44 universities (including 33 signatories of the Declaration of USR) reported 140 good practices. Practices have been divided into five categories: (1) ethical infrastructure and activities that foster academic values; (2) academic community engagement; (3) diversity management and anti-discrimination; (4) ethics in research; and (5) other.



The 2022 edition is a ,Catalogue of good practices of universities in ESG areas'. The good practices implemented by the universities were assigned in the Catalogue to relevant areas. The publication contains a collection of 146 practices from 53 universities that demonstrate the academic community's commitment to social responsibility and human rights. The largest number of practices related to category two - social impact. The exchange of good practices is a key element in the implementation of the concept of university social responsibility. Universities can benefit from the experience of other institutions that have already introduced USR into their strategy and are successfully implementing social responsibility projects. Examples of the benefits of sharing good practices include:


- 1. Access to good practice universities can learn about and apply good practice that has proven successful in other institutions.
- 2. Sharing knowledge and experience universities can benefit from the knowledge and experience of other institutions, as well as share their own, allowing for mutual enrichment.
- 3. Relationship building the exchange of good practice allows relationships to be built between universities, which can lead to further collaboration in the future.
- 4. Promoting USR universities can showcase their good practices and successes related to USR, which can help promote the institution and attract new students, staff and partners.

2) A catalogue of case studies in creating solutions for a sustainable future of higher education



The catalogue brings together 34 case studies from 34 universities with diverse profiles. These relate to five areas: Partnership for Purposes; Values - Equality, Diversity, Tolerance and Respect; Social Participation - Disability, Social Activation, Mental Health; Education of the Future and Care for the Natural Environment. The publication is enriched by expert articles summarising experiences in each of the above topics.

3) Guide to ESG legislation



As a result of a cooperation of the 17 Goals Campaign, the SGH Warsaw School of Economics and the Working Group on Social Responsibility of Universities and Ministry of Developments Funds and Regional Policy, which initiated the initiative, the ,Guide to ESG Legislation' was published. The aim of the publication is to support Polish companies in the process of sustainable transformation and effective implementation of ESG legislation. The guide maps 41 key pieces of European Union legislation in the environmental, social and governance areas that have an impact on doing business in Poland.



4) Events organised by the Working Group on USR

Since the start of operation of the Working Group on USR, 12 webinars, conferences and congresses have been held. During more than 23 hours of talks, debates and discussions, the most topical issues were addressed, awareness was built, inspiring solutions were presented and important questions were asked about the sustainable future of universities.

- The webinar entitled ,Due diligence in responsible business conduct', held on 27 May 2024, discussed, among other things, the proper understanding of the concept of due diligence, the elements of its implementation process and its place in the EU regulatory regime. It also discussed the challenges and difficulties faced by entrepreneurs during its implementation phase.
- On 25 May 2023, a webinar was held on ,Good practices of foreign universities in terms of social responsibility'. During the meeting, the results of the research project ,Good practices of foreign universities in terms of social responsibility' were presented, and international university rankings were discussed using the example of THE Impact ranking.
- On 21 March 2023, the Working Group on USR organised a webinar entitled ,Social responsibility of Polish universities through the eyes of internal stakeholders'. A report presenting the results of the survey ,Diagnosis of the implementation of the social responsibility of universities' was premiered at the event. A panel discussion on the challenges faced by universities in implementing social responsibility was also part of the programme. Representatives of the university's internal stakeholders participated in the meeting. The meeting concluded with a question and answer session.
- On 2 June 2022, the conference ,Experiences, practices and challenges of social responsibility of universities' was organised. The purpose of the meeting was: to present the experiences of universities implementing the principles of the Declaration of University Social Responsibility in practice, to learn about the benefits of cooperation between business and academic community, to discuss the achievements of the Working Group on USR to date and to present the Catalogue of Good Practices of Universities for 2021.

During the conference, representatives from a further 77 universities from all over Poland signed the Declaration of USR on behalf of their universities. A total of 160 Polish universities are now signatories of the Declaration.

On 24 May 2022, the webinar ,Organising university activities in accordance with the principles of the Declaration of University Social Responsibility' took place. Its participants discussed, among other things, how to organise university activities in practice in the context of implementing twelve principles of the Declaration and the role of the Rectors' Plenipotentiaries for USR. Another important highlight was the presentation of the research project ,Diagnosis of the implementation of the social responsibility of universities' carried out by the Working Group on USR. The meeting concluded with a question and answer session open to Group members.



- 'Current trends in the development of responsible business standards' was the topic of a webinar held on 12 May 2022. The then-current trends in responsible business and non-financial reporting issues in light of changing EU regulations were discussed. The OECD National Contact Point was also presented as an example of a remedial mechanism in situations of potential violations of the OECD Guidelines for Multinational Enterprises.
- On 14 December 2021, the webinar ,Zero waste best environmental practices of Polish universities' was held. Measures to reduce waste generated by universities are part of the implementation of the principles of the Declaration of USR and also contribute to the UN Sustainable Development Goals. The model of a circular economy in the context of climate change, practical ways to implement *zero waste* principle in university activities, as well as the experiences, challenges and needs of universities in terms of environmental protection were discussed.
- On 8 November 2021, the 26th Climate Change Summit (COP26) in Glasgow hosted a webinar on ,Disseminating knowledge on climate change and sustainable development'. Among other things, the aim of the meeting was to discuss the role of science in the context of climate challenges, as well as the specific mission of universities to shape responsible leaders for a sustainable future.
- An online conference, ,Report on the implementation of the Declaration of University Social Responsibility as a self-assessment tool', was held on 9 March 2021. The conference discussed the design of a new tool that supports universities in determining the level of implementation of the Declaration principles and diagnosing areas that need to be addressed. The meeting was an opportunity to consult the project with a wide range of stakeholders, as well as to discuss the experiences of Polish universities in social responsibility reporting.
- 'University Social Responsibility after the Covid-19 pandemic' was the topic of a webinar held on 20 November 2020. The event focused on the role of social responsibility in countering the spread of the pandemic. The debate focused on: how universities can support their stakeholders who remain in home isolation, what the impact of the pandemic experience may be on the development of the concept of social responsibility, and what challenges the epidemic has brought to universities for the fulfilment of their educational and scientific tasks.
- On 30 June 2020, a webinar was held on ,University Social Responsibility and the coronavirus pandemic. The aim of the meeting was to share experiences around activities directed at combating the virus, to strengthen cooperation between experts implementing USR in universities, as well as to disseminate the principles of the Declaration of USR and to spread awareness of the USR Working Group's activities.
- On 16-17 April 2019, the Congress on the Social Responsibility of Science Science for You took place. One of the aims of the congress was to promote knowledge and build interest in technological innovations. An important highlight of the programme was the accession of a further 60 universities as signatories of the Declaration of USR.

7. University self-assessment form on the implementation of the Declaration of USR

The Working group on USR has developed a self-assessment form on the implementation of the Declaration principles. The form is a tool to support the process of putting the principles of the Declaration into practice and evaluating actions taken in this regard. Questions/measures have been developed for each of the principles of the Declaration so that the university can assess whether it is taking the right actions to pursue a particular area of social responsibility.

7. Benefits of implementing the principles of the Declaration of USR Social responsibility is becoming increasingly important as a concept that organises the interdependence of an organisation and the environment, given that in the modern world, the functioning of all the actors of socio-economic life has a diverse impact on the surrounding reality, generating interconnections, the nature of which is of vital importance for the quality of social life.

It is often included in university strategies, as educational institutions play a key role in shaping future leaders, innovators and experts who will have an impact on society.

Universities that undertake community activities can increase their value to society, enhance their reputation and attract better students, staff and business partners.

Figure. Dimensions of university social responsibility

Social sustanability	The university can work towards environmental protection and sustainanility, e.g. by reducing greenhouse gas emissions, reducing energy consumption, promoting recycling and reducing waste.
Social inclusion	The university can work towards social inclusion, through scholarship programmes for students from smaller towns or support programmes for students from lower-income families.
Ethics and values	The university should promote ethical values and attitudes among its students and staff, e.g. by providing ethics and integrity training.
Research and innovation	The university can work to develop innovations that have a positive impact on society and the environment, e.g. through research into renewable energy, energy efficiency technologies or innovations in the area of health.
Working with the local community	The university can contribute to the local development of the local community, for example by organising free workshops for local businesses or providing assistance in difficult situations such as natural disasters.
