

ORDER No. 5/2023
OF THE HEAD OF DOCTORAL SCHOOL
Of the Maria

of 2 October 2023

on the amendment of the Order of the Head of the Doctoral School No. 6/2021 of 17 December 2021 on the guidelines for open lectures delivered as part of the curriculum at the Doctoral School of the University

Pursuant to § 12(7) of the Regulations of the Doctoral School of the Maria Grzegorzewska University, adopted by Resolution No. 138/2019 of the Senate of the University of 20 March 2019 on the adoption of the Regulations of the Doctoral School run by the Maria Grzegorzewska University, as amended, the consolidated text of which constitutes Appendix No. 7 to Resolution No. 523/2023 of the Senate of the University of 22 March 2023, I order as follows:

§ 1

1. Open lectures as part of the curriculum of the Doctoral School are carried out as part of the following subjects: *Interactive lectures with outstanding researchers; Trends in social science; Lecture by visiting professor.*
2. In the case of a *Lecture by visiting professor*, one of the persons granted the status of visiting professor in accordance with the Order No. 214/2021 of the Rector of the University of 30 June 2021 as amended in a given academic year is invited to deliver it. The lecture is organized in consultation with the Office of Foreign Relations. The visiting professor performs teaching duties in accordance with the agreement and gives credit for the course.
3. The procedure for organizing the remaining open lectures is as follows:
 - 3.1.1 The Scientific Council of the Doctoral School of the University proposes a list of scientists agreed upon at the first meeting of the Council in a given academic year, taking into account the proposals of doctoral students;

- 3.1.2 Doctoral students select lecturers from this list taking into account the guidelines for each lecture (according to Appendix No. 1 to this Order);
 - 3.1.3 The list of proposed researchers approved by the Head of the Doctoral School is sent to doctoral students;
 - 3.1.4 Each first-year doctoral student should demonstrate a commitment to organizing at least one open lecture falling within the first year of his or her education at the doctoral school;
 - 3.1.5 In the case of fewer or more doctoral students per year than the number of open lectures planned and feasible, doctoral students may cooperate with each other;
 - 3.1.6 Detailed tasks of doctoral students related to the organization of open lectures are included in Appendix No. 1 to this Order.
 - 3.1.7 In order to organize and implement the open lecture, the doctoral student acts in consultation with the staff of the unit carrying out the duties of the Secretary's Office of the Doctoral School, which is responsible for the formal side of the organization of the lecture.
- 4. The Model schedule of open lectures for doctoral students of the Doctoral School is adopted, in accordance with Appendix No. 1 to this Order.
 - 5. The model of the credit report in the wording as contained in Appendix No. 2 to this Order is adopted.

§ 2

The Order comes into force on the date it is signed.
